



# RESIDENTIAL GARBAGE COLLECTION EXEMPTION FORM FOR BUSINESSES



Garbage service is mandatory in Franchise Area 3 (generally defined by the area within Placer County east of Donner Summit to Lake Tahoe) if the home or business is occupied in any form during a defined service quarter (Placer County Code Section 8.16.220). However, business owners can comply with the mandatory service by self-hauling their residential garbage to their business in Franchise Area 3 by applying for a yearlong exemption. To qualify, check the boxes below to certify that:

- The business and primary residence must both be located within Franchise Area 3 (*documentation required*).
- Only one exemption shall be granted per business and shall only apply to the primary owner (*documentation required*).
- The business must have an active and appropriate minimum level of service to serve both the business and residence.
- The business must be free of any ongoing public health issues and remain in good standing with the Department of Public health.
- I will not dispose of my household waste in any other business's bins or in any public bins.

**If the business fails to remain free of public health issues or maintain solid waste service, the primary residence associated with the business will be placed on service and billed for the entire year.** This exemption request must be submitted annually within the request timeframe of November 15 – December 15 prior to the year of the requested service exemption, accounts will not be adjusted in arrears.

**Documentation is required** to prove that the person requesting the exemption is the primary business owner and that the residence receiving the exemption from mandatory garbage collection service is the business owner's primary residence.

To show that you are the **primary business owner**, please submit a copy of your **business license**.

To show that the property receiving the exemption is your **primary residence**, please submit a copy of your **property tax bill for the residence**. Alternate forms of documentation that the property is your primary residence may be accepted on a case-by-case basis. Utility bills will not be accepted as proof of primary residence.
